

Eligibility Requirements:

Any member of the Snohomish County USBC may submit nominations for the Hall of Fame. Candidates for the Hall of Fame must meet the following criteria:

- Candidate must be a minimum of forty (40) years of age as of July 1st of the year the nomination is submitted, requirement waived for posthumous induction.
- Candidate must have been an adult member of the Snohomish County USBC continuously for the past ten (10) years.
- For the category of **Superior Performance**, candidate must have a minimum of ten (10) years of participation in local leagues and local, state, and national championship tournaments.
- For the category of **Meritorious Service**, candidate must have a minimum of ten (10) years of service to the Snohomish County USBC.
